# **Updated Guidelines for the Use of Golf Carts**

Dear Members,

This is to reiterate and provide clarity on the rules and regulations regarding the use of golf carts:

### 1. Authorized Use:

- Only members are permitted to drive and operate golf carts.
- Caddies are prohibited from driving golf carts unless prior permission is granted.

## 2. Permission for Caddy Use:

- If a member is unable to drive his golf cart, prior permission must be obtained for it to be operated by a caddy. Members can submit requests via email at tollygolf1@gmail.com. Alternatively, a written request may be left at the Proshop, Club Office, or Club Reception. The request should include the name(s) of the caddy/caddies.
- ➤ The Committee and office will review the request and grant permission to members and caddies where appropriate. Approved caddies will be notified to the Pro shop too and only they will be authorized to receive the cart key.

### 3. Course Safety:

Please adhere to designated cart pathways and avoid driving on the rough or fairway to prevent damage to the course.

#### 4. Club Roads:

Follow vehicle direction signage on the club's inner roads to prevent accidents

Members are requested not to take golf carts to their vehicles in the car park for loading / unloading their golf sets. Caddies will assist transporting golf sets from the gravel area to the car park.

## 5. Driving Conduct:

- Always remain seated in the golf cart, all limbs within the cart's boundaries.
- Driving under influence of alcohol/any intoxicating substances is prohibited.

## 6. Liability in Case of Accidents:

- Any accident resulting in property damage or injury will be assessed on a case- by- case basis.
- Members will bear liability for such incidents. Based on the committee's determination of culpability, golf cart privileges for the member may be revoked.
- If a caddy is found responsible, disciplinary action, including barring them from caddy duties, may be taken.

Members who wish to permit a caddy to operate their golf cart on their behalf are requested to follow the process outlined in Point 2.

These guidelines will take effect from **Tuesday 7<sup>th</sup> January**, **2025**. We urge all members to adhere to these rules and ensure their caddies comply. Your cooperation is vital for maintaining safety and order within the club.
